UNSCR 1267 Implementation Practices and Enforcement Obligations Directives No. 1 of 2013

- 1. These Directives shall be cited as the United Nations Security Council Resolution (UNSCR) 1267 Implementation Practices and Enforcement Obligations, Directives No. 1 of 2013.
- United Nations Regulations No. 2 of 2012 (hereafter referred to as Regulations) was promulgated by the Minister of External Affairs under Section 2 of United Nations Act No.45 of 1968 and implemented through Gazette Notification No. 1760/40 dated 31 May 2012.
 - (i) Objective of these Regulations is to facilitate the implementation of obligations, relating to the freezing of funds and the prohibitions on availability of assets under paragraph 4(b) of UNSCR 1267 (1999) and other related paragraphs and the modification and

strengthening set-out in the subsequent UNSCRs, in particular paragraph 1 of Resolution 1988 (2011) and 1989 (2011) within Sri Lanka and thereby specify a means to comply with the aforesaid obligation.

(II) For the purpose of implementation of the Regulations, Chief of National Intelligence of Ministry of Defence has been appointed as Competent Authority by the Minister of External Affairs in consultation with Minister of Defence & Urban Development.

In order to expeditiously and effectively implement the provision of above Regulations, the following procedure shall be followed.

- 3. The communication of updates to the list of designated individuals and entities would be as follows:
- (i) The Ministry of External Affairs shall electronically forward any updates to the list of individuals and entities subject to UN Sanctions measures upon any revision (referred to as designated list) to the Competent Authority, Financial Intelligence Unit of Sri Lanka (FIU) and Legal / UN Division of Ministry of External Affairs.
- (ii) The FIU Sri Lanka would electronically forward the updates mentioned in (i) above to the Licensed Banks (LBs), Licensed Finance Companies (LFCs), Insurance Companies (ICs), Stock Brokers (SBs), Authorized Money Changing Companies (AMCCs) and any other institutions as the case may be and to the relevant regulatory/supervisory authorities.
- (iii) The Competent Authority would forward the same updates to the designated list to the authorities/agencies that register movable and immovable property, custom authority, immigration authority and appropriate law enforcement agencies.
- (iv) The Competent Authority would forward the same updates to the designated list to the Regulatory / Supervisory Authorities for nonprofit organization so such authorities may assist in preventing such organizations from making available any funds, financial assets or economic resources to designated individuals and entities.
- 4. With regard to Actions to be taken on funds, financial assets or economic resources held in the form of bank accounts, stocks or insurance policies etc., the FIU would forward updates to the designated lists to the LBs, LFCs, ICs, SBs AMCCs and any other institution as the case may be requiring them to;
 - (i) Maintain updated lists of persons and entities designated and check on the given parameters on a regular basis to verify whether individuals or entities so listed collectively hereinafter referred to as designated individuals / entities are holding with

them any funds, financial assets or economic resources in the form of bank accounts, stocks or insurance policies etc., with them.

- In case the particulars of any of the customers match with the particulars of designated individuals/entities, the LBs, LFCs, ICs, SBs AMCCs and any other institution as the case may be shall immediately, freeze the particular assets, and inform full particulars of the funds, financial assets or economic resources held in the form of bank accounts, stocks or insurance policies etc. and subsequent attempted transactions on such frozen assets to the FIU on the same business day by fax No.011-2477692 and also convey over the telephone on 011-2477125. The particulars apart from being sent by post (to Financial Intelligence Unit, Central Bank of Sri Lanka, No: 30, Jandhipathi Mawatha Colombo-1) should necessarily be conveyed on e-mail:- fiu@cbsl.lk.
- (III) The LCBs, RFCs, ICs, SBs, AMCCs and any other institution as the case may be shall also send by post (to Chief of National intelligence, Office of the Competent Authority Ministry of Defence & Urban Development No. 15/5 Baladaksha Mawatha Colombo) a copy of the communication mentioned in (ii) above to the, Chief of National Intelligence of Ministry of Defence & UD. The particulars apart from being sent by post should necessarily be conveyed on e-mail: cniofficemod@gmail.com
- (iv) In the event that there is a match of any of the customers with the particulars of designated individuals/entities, the LCBs, RFCs, ICs, SBs, AMCCs and any other institution as the case may be shall not make available any funds, financial assets or economic resources directly or indirectly to or for the benefit of any such designated individuals/entities and shall prevent them from conducting any transactions.
- (v) This process shall take place without prior notice, to the designated individuals/entities.
- Actions to be taken with regard to economic resources in the form of movable or immovable properties
 - (i) Competent Authority would electronically forward any updates to the designated lists to the authorities performing the work of registration of movable and immovable properties, custom authority and Regulatory / Supervisory Authorities for nonprofit organization.
 - (ii) In the event that there is any match with the designated individuals/entities, the authorities /agencies that register movable and immovable properties, custom authority, Regulatory / Supervisory Authorities for nonprofit organization would immediately freeze performing the work of registering the particular assets or permitting any transfer of an asset and keep note on the existing registration status of the property as an asset subject to freezing under Regulation 2 and communicate the complete particulars of such individuals/entities along with

complete details of movable and immovable properties to the Chief of National Intelligence of Ministry of Defence & Urban Development immediately on the same business day by fax No. 011-2390288 and also convey over the telephone on 011-2396072. The particulars apart from being sent by post (to Chief of National intelligence, Office of the Competent Authority Ministry of Defence & Urban Development No. 15/5 Baladaksha Mawatha Colombo) should necessarily be conveyed by e-mail: cniofficemod@gmail.com.

- (iii) This process shall take place without prior notice, to the designated individuals/entities.
- 6. FIU and relevant regulatory/supervisory authorities appointed as Compliance Monitoring Authorities for LCBs, RFCs, ICs, SBs AMCCs and any other institution as the case may be under the Regulations shall:
 - (i) Issue directives rules and guidelines to LCBs, RFCs, ICs, SBs AMCCs and any other institution as the case may be in relation to implementation practices and enforcement of obligations under the Regulations.
 - (ii) Carry out examination for the purpose of ensuring compliance with the above Regulations and directives rules and guidelines issued under these Regulations.
 - (iii) Impose administrative sanction on any violation of an obligation under the Regulations.
 - (iv) Conduct training /awareness on matters relating to the Regulations.
- 7. Competent Authority will Monitor Compliance of the authorities performing the work of registration of movable and immovable properties, custom authority and Regulatory / Supervisory Authorities for nonprofit organization.
